(b) As an oral preparation or as a suppository -

Hydrocortisone cream 0.5 - 1%,

Metronidazole

Naproxen

Mupiricin

(c) As a cream -

(d) As an ointment -

- 1. In relation to the following Schedule 8 drug only, to the extent necessary to practise podiatry, the registrant, as a podiatric surgeon is qualified to:
  - (a) prescribe oxycodone (in short-acting form) as an oral preparation; or
  - (b) give someone, who may administer oxycodone (in short-acting form), a written instruction to administer the drug as an oral preparation.

The registrant must not prescribe or give a written instruction to administer more than 10 doses of

2.	As a podiatric surgeon, the registrant is qualified to prescribe, supply or administer following Schedule 4 drugs only:

Unless otherwise specified above, the maximum quantity of an S4 drug listed above that may be provided by a podiatric surgeon to any person, whether by direct supply or prescription or both, in the course of treating that person for a particular condition, is that usually required for 10 days' treatment of the condition with that drug.

3. To the extent necessary to practise podiatry, the registrant, as a podiatric surgeon is qualified to prescribe:

Dicloxacillin (as an oral preparation, with a maximum dosage for a person's condition not

exceeding that usually required for a 10 day course of treatment)

Fexofenadine (as an oral preparation, with a maximum dosage for a person's condition not

exceeding that usually required for a 10 day course of treatment)

- 4. To the extent necessary to practise podiatry, the registrant, as a podiatric surgeon is qualified to:
  - (a) obtain or administer the following Schedule 4 drugs only:
    - (i) dexamethasone, for local injection only; or
    - (ii) ropivacaine of a strength of 1% or less; or
  - (b) possess the drugs mentioned in paragraph (a) at the place where the registrant practises as a podiatrist.
- 5. To the extent necessary to practise podiatry, the registrant, as a podiatric surgeon is qualified to administer:
  - (i) adrenalin when combined with lignocaine, bupivacaine or prilocaine; or
  - (ii) felypressin when combined with prilocaine
