1. Is the content of the updated *Professional capabilities* clear and reflective of autonomous and contemporary medical radiation practice? If no, please explain why.

AIDH welcomes that the Board:

- acknowledged the critical importance of understanding health data, emerging technologies (including artificial intelligence), and digital health for medical radiation practitioners in brief, the importance of a digitally enabled workforce;
- added digital health capabilities, data management and health informatics to support the provision of care to the updated *Professional capabilities*; and
- referred to the Australian Digital Health Capability Framework to develop the key capabilities of Use of Health data, Digital health systems and Use of Health informatics.

We also welcome the acknowledgement that digital determinants of health can exacerbate health literacy issues.

We acknowledge the Board's note that 'updated guidance on minimum capabilities for medical radiation practitioners with respect to Digital Health including Artificial intelligence may be published by the Board within the lifecycle of the Professional capabilities.'

We recommend that the Board consider developing a framework specific to medical radiation practitioners, similar to the frameworks that were developed for the nursing and midwifery, and for the allied health professions (both frameworks are available at https://digitalhealthworkforce.org.au/strategies-frameworks/).

We would welcome working with the Board on such a project.

2. Is there any content that needs to be changed, removed or added in the updated *Professional capabilities?* If yes, please provide details.

It is our view that the Board has satisfactorily adopted AIDH recommendations to Ahpra's consultation on draft guidance for professional capabilities (available here: https://digitalhealth.org.au/wp-content/uploads/2024/12/FINAL_AIDH_PUB_sub_Ahpra-draft-guidance-on-professional-capabilities.pdf) and our recommendation that some formative level digital health capabilities should be integrated by the industry in their own right, and other ADHCF capabilities could be assimilated within other professional capabilities.

Reminder, the recommendation was to:

- 1. Adopt as standalone Digital Health capabilities:
 - A2 Procedural Knowledge Use of digital tools in healthcare in a way that aligns with procedural, policy, legal and ethical requirements

- D1 Information Sources Understanding the range of health information/data sources available and how and why these may be linked and analysed
- D2 Reasoning and Evaluation Evaluation of data and use of critical reasoning to provide information to support decision making and informed use of digital health applications
- E1 Appropriate Technologies Understanding the variety of digital health technologies available and identifying appropriate options
- E2 Digital Health Controls Understanding and demonstrating the use of effective controls to ensure safe and appropriate application of digital health
- 2. Integrate into other professional capabilities:
 - B3 Leadership through digital change Embracing the future of digital health through engaging with emerging technologies, accepting change, and participating in decision making
 - C1 Quality in Data Capture Understanding own role in data capture and ensuring the collection of accurate information
 - C2 Use of information Understanding how health information may be used and applying this as relevant to own role
 - C3 Data integrity for Decision Making Understanding the importance of data integrity and how data and information translate to real-world action and change

Further, we recommend that the Board add an enabling component about the need to maintain currency of skills and knowledge with digital systems and tools (this could be added to Domain 1 Key Capability 5).

We note that Domain 1 Key Capability 5 makes specific references to Artificial Intelligence (AI) as it relates to bias, regulation and national frameworks for safe use. Those aspects are not specific to AI and can apply to digital health systems and tools in general.

As the Board noted in its 2022 Statement on Artificial intelligence, medical radiation practitioners work with AI across a broad range of clinical and non-clinical roles. The statement mentions a number of aspects that medical radiation practitioners need to be across. There is an opportunity for the Board to add a Key capability specific to AI to address matters such as understanding inputs and outputs.
