Eligible offshore courses – Categories B and F

Eligibility

For the Competent Authority pathway categories B and F, the Medical Board of Australia will accept applicants who have successfully completed an accredited medical course undertaken in the competent authority country (United Kingdom or Ireland) or undertaken wholly or partially outside the competent authority country. To be eligible for the Competent Authority pathway, via a course conducted wholly or partially outside the competent authority country, they must be on this list. This list will be reviewed regularly.

Some offshore courses are no longer offered, but their past graduates can continue to apply for the Competent Authority pathway.

IMU University in Malaysia has a partnership arrangement with some GMC-accredited universities in the UK. Students start their medical studies at IMU and complete the first years of study in Malaysia. They then transfer to a GMC-accredited university in the UK and receive credits for subjects successfully completed. Graduates are awarded a GMC-accredited qualification from the UK and are eligible for category B. As this is a course transfer and the study in Malaysia is not provided by the UK university, they are not 'offshore' courses and are not on this list.
