# Draft proposed professional capabilities and accreditation standards for podiatry and podiatric surgery

In 2019 the Podiatry Board of Australia requested that the Podiatry Accreditation Committee (the Committee) review and update the professional capabilities and accreditation standards for podiatry and podiatric surgery to ensure the documents reflect contemporary practice. This includes reviewing and updating:

- Threshold professional capabilities for:
  - Podiatrists
  - o Podiatric surgeons
- Accreditation standards for:
  - o Entry-level podiatry programs
  - o Podiatric therapeutics programs for registered podiatrists and podiatric surgeons
  - Registered podiatrists addressing requirements for endorsement of registration in relation to scheduled medicines (ESM programs)
  - Podiatric surgery programs

## Approach to consultation

From mid-July to mid-September 2020, the Committee undertook a confidential phase of preliminary consultation with key stakeholders including universities, professional associations and jurisdictions (the Commonwealth and state/territory health agencies). Preliminary consultation enabled the Committee to test proposals in the initial draft of the draft proposed professional capabilities and draft proposed accreditation standards and refine them before proceeding to public consultation. It also gave stakeholders an opportunity to provide feedback to improve the clarity of the documents.

The Accreditation Committee has refined the documents to reflect stakeholders' feedback and is now releasing this consultation paper, the draft proposed professional capabilities and the draft proposed accreditation standards for feedback from any interested stakeholders and individuals.

## Explanatory material to accompany consultation papers

### **Overview**

The Health Practitioner Regulation National Law, as in force in each state and territory (the National Law), established the Podiatry Board of Australia (the Board) to begin national regulation of the profession from 1 July 2010.

Podiatrists and specialist podiatric surgeons in Australia are regulated by the National Law and must be registered with the Board. Only individuals who hold current registration with the Board are permitted to use the professional title of podiatrist or podiatric surgeon in Australia. Registered podiatrists and podiatric surgeons must comply with the Board's standards, codes and guidelines, including engaging in professional development and practice to continuously maintain clinical competence and professional practice.

In 2019 the Podiatry Board of Australia requested that the Podiatry Accreditation Committee review and update the professional capabilities and accreditation standards for podiatry and podiatric surgery to ensure the documents reflect contemporary practice. The review commenced in late 2019 and will be completed in early 2021.

The Accreditation Committee is now undertaking public consultation on the draft proposed professional capabilities and accreditation standards for podiatry and podiatric surgery, including:

- Draft proposed threshold professional capabilities for:
  - Podiatrists (Attachment A1)
  - Podiatric surgeons (Attachment A2)
- Draft proposed accreditation standards for:
  - Entry-level podiatry programs (Attachment B1)
  - Podiatric therapeutics programs for registered podiatrists and podiatric surgeons (Attachment B2)
  - Registered podiatrists and podiatric surgeons addressing requirements for endorsement of registration in relation to scheduled medicines (ESM programs) (Attachment B3)
  - Podiatric surgery programs (Attachment B4)
  - Summary of draft proposed accreditation standards (Attachment B5)

Professional capabilities identify the knowledge, skills and professional attributes needed to safely and competently practise as a podiatrist or podiatric surgeon in Australia. They describe the threshold or minimum level of professional capability required.

Accreditation standards are used to assess whether a program of study, and the education provider that provides that program of study, provide persons who complete the program with the professional capabilities needed to safely and competently practise in Australia.

Accreditation standards require education providers to design and implement a program where the curriculum maps to the professional capabilities specified in the standards. Accreditation of a program assures the Board and the community that students graduating from the accredited podiatric program have the knowledge, skills and professional attributes needed to safely and competently practise as a podiatrist or podiatric surgeon in Australia.

The Accreditation Committee accredits programs of study that meet the accreditation standards and monitors approved programs and education providers to ensure they meet and continue to meet the accreditation standards. Graduates of an accredited and approved podiatry or podiatric surgery program are qualified for general registration to practise as an entry-level podiatrist or qualified for specialist registration as a podiatric surgeon. The Board considers approving an accredited program as providing a qualification for registration purposes, based on its accreditation by the Accreditation Committee. The Board does not directly examine or assess the capability of applicants for registration who have completed their podiatric education in Australia and hold an approved qualification.

## Approach to the draft proposed professional capabilities and accreditation standards

The Committee's approach to the draft proposed professional capabilities and accreditation standards has been based on a comprehensive review of professional capabilities and accreditation standards nationally and internationally, including a cross-profession analysis of professional capabilities, accreditation standards and processes for all health professions within the National Scheme. This public consultation phase gives stakeholders an opportunity to provide feedback to the Accreditation Committee on the draft proposed professional capabilities and the draft proposed accreditation standards.

The draft proposed professional capabilities and accreditation standards emphasise safe practice, cultural competence, and outcomes relevant to the expected competence of graduates. The draft proposed professional capabilities are structured around five domains, that are supported by key capabilities and enabling components. The five domains are:

Domain 1:	Podiatrist (or podiatric surgeon)
Domain 2:	Professional and ethical practitioner
Domain 3:	Communicator and collaborator
Domain 4:	Lifelong learner
Domain 5:	Quality and risk manager

The draft proposed accreditation standards are structured around five standards, supported by criteria that set out expectations for an education provider and its program to meet the accreditation standard and expected information that education providers will be asked to submit for each accreditation standard as part of their accreditation application or monitoring response. The five standards are:

Standard 1:	Assuring safe practice
Standard 2:	Academic governance and quality assurance of the program
Standard 3:	Program design, implementation and resourcing
Standard 4:	The student experience
Standard 5:	Assessment

## The relationship between the Board's requirements for endorsement for scheduled medicines and accreditation decisions

Endorsement of registration identifies practitioners with additional qualifications and specific expertise. A podiatrist or podiatric surgeon whose registration is endorsed for scheduled medicines under section 94 of the National Law is qualified to administer, obtain, possess, prescribe, sell, supply or use Schedule 2, 3, 4 or 8 medicines for the treatment of podiatric conditions, as listed in the *National podiatry scheduled medicines list*<sup>1</sup> and in accordance with the relevant legislation and regulations in each state or territory in which they are practising.

In 2018, following approval from the COAG Health Council, the Podiatry Board of Australia introduced a revised registration standard and guidelines for the endorsement for scheduled medicines (ESM registration standard). The ESM registration standard describes the Board's minimum requirements for a podiatrist or podiatric surgeon to have their registration endorsed for scheduled medicines.<sup>2</sup>

The registration standard outlines two pathways for endorsement:


- Pathway A: Approved Qualification Pathway or
- Pathway B: Supervised Practice Pathway under the Board's *Registration Standards: Endorsement for scheduled medicines*<sup>3</sup>.

### Pathway A: Approved qualification pathway

Under Pathway A, a podiatrist or podiatric surgeon is qualified for endorsement after completing a qualification that is approved by the Board for the endorsement for scheduled medicines (or another qualification that the Board deems to be substantially equivalent to, or based on similar competencies to, an approved qualification in endorsement for scheduled medicines).

Pathway A is shown in Figure 1 below.

#### Figure 1: Pathway A to endorsement for scheduled medicines



### Pathway B: Supervised practice pathway

Under Pathway B, a podiatrist or podiatric surgeon is eligible for endorsement for scheduled medicines after completing an approved qualification in podiatric therapeutics (or another qualification that the Board deems to be substantially equivalent to, or based on similar competencies to, an approved qualification in podiatric therapeutics) **and** undertaking additional requirements as outlined in the Board's *Guidelines: Endorsement for Scheduled Medicines* and *Registration Standard: Endorsement for Scheduled Medicines*<sup>4</sup>.

The additional requirements in the Board's Guidelines: Endorsement for Scheduled Medicines are:


- successful completion of approved online case studies,
- a period of supervised practice, and
- development of a portfolio of evidence for assessment by the Board.

Pathway B is shown in Figure 2 below.

#### Accreditation decisions

When the Accreditation Committee reports on its accreditation decision to the Board under section 48 of the National Law, it will identify if, in addition to addressing professional capabilities for general registration as a podiatrist or specialist registration as a podiatric surgeon, the accredited program:

- a. included education in podiatric therapeutics that covers the theoretical foundation for endorsement to ensure graduates can safely and competently commence their supervised practice for Pathway B of the ESM registration standard
- b. included education and training in podiatric therapeutics and clinically-supervised practice to ensure that graduates have the professional capabilities required to administer, obtain, possess, prescribe, sell, supply or use Schedule 2, 3, 4 or 8 medicines for the treatment of podiatric conditions, as listed in the *National podiatry scheduled medicines list*.

### **Options for education providers**

Podiatrists and podiatric surgeons who meet the Board's requirements for endorsement of their registration in relation to scheduled medicine currently do so via Pathway B because there are not yet any approved qualifications for Pathway A.

The proposed accreditation standards are designed to provide an option for education providers to seek accreditation of programs they want the Board to approve as providing qualifications for Pathway A. The Board may approve a program as providing a qualification suitable for Pathway A if the Accreditation Committee advises the Board that the curriculum includes education and training in podiatric therapeutics and clinically-supervised practice to ensure that graduates have the professional capabilities required to administer, obtain, possess, prescribe, sell, supply or use Schedule 2, 3, 4 or 8 medicines for the treatment of podiatric conditions, as listed in the *National podiatry scheduled medicines list*.

Education providers also have the option to seek accreditation of programs they want the Board to approve as providing qualifications for Pathway B. The Board may approve a program as providing a qualification in podiatric therapeutics suitable for Pathway B if the Accreditation Committee advises the Board that the curriculum includes learning and assessment of the theoretical foundation for endorsement to ensure graduates can safely and competently commence their supervised practice.

Education provides may also seek accreditation of programs they want the Board to approve as providing qualifications for general registration as a podiatrist or specialist registration as a podiatric surgeon. The Board may approve a program as providing a qualification suitable for general registration as a podiatrist or for specialist registration as a podiatric surgeon if the Accreditation Committee advises the Board that the curriculum includes learning and assessment of the relevant professional capabilities.
