Dear Mr Fletcher

I am writing to you in relation to the funding determination for the 2019-20 financial year, as required under section 26A of the *Health Practitioner Regulation National Law (Queensland)* (National Law).

The National Law requires consultation with a number of entities, including the Australian Health Practitioner Regulation Agency (AHPRA). Thank you for your response on behalf of AHPRA and the National Boards to the consultation paper on the proposed determination dated 29 May 2020. I note that consultation feedback received to date has endorsed the proposal.

I can now confirm my decision that for the 2019-20 financial year, the total sum of the complaints component of registration fees payable by Queensland health practitioners is \$4,144,436. I have enclosed a summary of the amounts payable by each of the National Boards. In accordance with the National Law, could you please ensure that the National Boards are notified of the required contributions and that you publish this decision as soon as practicable.

As part of its operational budget process, the Queensland Department of Health has already made payment to the Office of the Health Ombudsman, on account of the estimated funding determination sum, and requests that the 2019-20 final funding determination payment of \$4,144,436 be made directly to the Department.
