# Putting Patients first: New guidelines for cosmetic Procedures

There are new guidelines for registered health practitioners who perform cosmetic procedures, such as injections and fillers. Under the guidelines, practitioners will need more training before they can do procedures and they are not allowed to use edited or misleading images in their advertising. There is also a mandatory seven-day cooling off period for people under the age of 18.

#### Review of National Scheme to Put greater focus on timeliness and **exPeriences**

Health Ministers recently accepted a report into the National Registration and Accreditation Scheme (the Scheme) that looks at ways to standardise how professions are regulated, reduce complexity in our processes to improve peoples' experiences and continue our work on proactive regulation that prevents harm. Ahpra and National Boards have welcomed the review and have begun work in a number of areas to make recommended improvements.
