

Accreditation fees for Aboriginal and Torres Strait Islander health practice

Information for education providers

The Aboriginal and Torres Strait Islander Health Practice Accreditation Committee (the Committee) sets the fees for accreditation assessments, monitoring and annual accreditation on a cost recovery basis and the Aboriginal and Torres Strait Islander Health Practice Board of Australia (Board) approves the fees. The fees are reviewed on a regular basis and may change from time to time.

Fees for accreditation and transitional assessment

The current approved fee for initial accreditation assessment of an Aboriginal and Torres Strait Islander primary health care practice program (program) from one campus or location is \$4,169 (GST free). This amount applies until 31 December 2026.

This fee includes one site visit to one campus or location. Different fees apply if:

- an assessment team needs to undertake a site visit to more than one campus or location, for example if the qualification is delivered from more than one campus or location, and / or
- the assessment team needs to undertake extra site visits because evidence and requested information is not provided to them at the first site visit.

A full accreditation assessment may not be required for programs that have completed an assessment against the 2019 *Accreditation Standards for Aboriginal and Torres Strait Islander Health Practice*. With the recently published 2025 *Accreditation Standards for Aboriginal and Torres Strait Islander Health Practice*, education providers may be assessed via a transitional assessment to determine how the education provider and its program meet the revised standards or a full accreditation assessment will be required if seven years from assessment date.

Annual and monitoring fees

The annual accreditation fee helps to support the work of the Committee to ensure it continues to be satisfied that each education provider on the Board's list of approved programs continues to meet the accreditation standards. This work is required under the Health Practitioner Regulation National Law as in force in each state and territory (National Law).

The fee does not include the cost of any site visits or a detailed accreditation assessment of an education provider on the Board's list of approved programs. Additional fees apply if the Committee decides that, based on its monitoring of a particular approved program, a site visit / monitoring visit or detailed accreditation assessment is required to ensure the Committee continues to be satisfied the program and provider meet the accreditation standards.

The introduction of the condition or monitoring requirement fee commences in 2026. If the Committee imposes a new condition or monitoring requirement on an existing program the fee will not be applied as the education provider will have 12 months to respond. If the education provider submits a second response to the condition and/or monitoring requirement and the Committee agrees it continues to not be met, then the Committee may impose the fee. The fee will be applied on an annual basis until the condition and/or monitoring requirement is addressed. The Committee can also decide if other monitoring tools may be applied instead of the fee such as meeting with program/executive staff either in person or via videoconference or a monitoring visit is required.
