## Communique – November 2024

The Aboriginal and Torres Strait Islander Health Strategy Group (Strategy Group) is Co-chaired by Karl Briscoe, CEO of the National Association of Aboriginal and Torres Strait Islander Health Workers and Practitioners (NAATSIHWP) and Associate Professor Dr Carmen Parter, Ahpra Board member.

The Strategy Group members held a joint meeting with the Ahpra Board on the 12 November 2024 as per the Terms of Reference with the Strategy Group meeting held on the 13 November 2024. Both meetings were held face to face in Brisbane, Queensland.
