First Queensland health practitioner data released

The first ever comprehensive data on health practitioner regulation is now available with the release of AHPRA and National Boards' annual report, including state and territory information.

The release of the 2010-11 annual report gives an essential, first-ever insight into Australia's 530,115 health practitioners across 10 professions regulated under the National Registration and Accreditation Scheme (the National Scheme). One in 44 Australians is a registered health practitioner.

As well as profiling the professions and practitioners by state and territory, the report provides the first national data on notifications (complaints) involving health practitioners and the actions taken by National Boards to protect public safety.

AHPRA CEO Mr Martin Fletcher said the 2010-11 annual report demonstrated transparent and accountable reporting by AHPRA and the National Boards about their work in regulating the professions and protecting the public.

"The introduction of the National Scheme on 1 July 2010 represents an unparalleled reform of health practitioner regulation. This annual report provides comprehensive data about the first year of operation of the National Scheme, across all areas of activity of AHPRA and the National Boards," Mr Fletcher said.

"There is now clear evidence that the National Scheme is sound, robust and a great asset for the Australian community," he said.

Features of health practitioner regulation in Queensland during the 2011 reporting year include:

- There were 99,200 practitioners across 10 professions who nominated Queensland as the principal place of practice in 2010-11, representing 18.7% of Australia's registered health practitioners (Tables 4 and 6)
- There are 1,795 health practitioners in Queensland with an endorsement on their registration (eq: 155 nurse practitioners; 629 nurses and midwives and 158 optometrists endorsed for scheduled medicines; 53 eligible midwives; seven dental practitioners endorsed for conscious sedation; and 792 psychologists with area of practice endorsement) (Table 9)
- Queensland has 10,657 specialists 294 dentists and 10,362 medical practitioners; one podiatric surgeon (Table 12)
- There were 1924 notifications received in the AHPRA Queensland office in 2010-11, which means that 1.6% of Queensland practitioners were subject to a notification. Consistent with all other states and territories, the largest group of these (1,050 notifications) related to medical practitioners and 243 to nurses (Tables 13 and 14)

85 mandatory notifications were received during the year in the AHPRA Queensland office. This represents a rate of 8.6 mandatory notifications per 10,000 Queensland practitioners or 19.9% of the national total of mandatory notifications, excluding NSW (Table 22)

The annual report is an important source of information about the activities of the National Boards in 2010-11 and highlights for AHPRA's state and territory offices. The Tables referred to above are published in the annual report.

Analysis of national registration and notifications data in the annual report, including trends and comparisons, is published in the 2011 annual report edition AHPRA Report. It is recommended that state and territory media releases are read in conjunction with this information, to enable informed comparisons to be made.
