Thank you for the opportunity to comment on this consultation paper.

We have consulted with our stakeholders and have the following comments to make.

- 1. The proposed option number 5 has considerable merit.
- 2. The benefits are that this covers potential fraudulent activity, is fair to all concerned and does not increase the cost of running AHPRA. It is the only way in which all Australian jurisdictions, health units etc. can be reassured of a clear criminal background of the doctors in their service
- 3. A problem with all of the options is that they still require applicants to declare that they have lived in another country. If they do not declare, then no checks will be done. So if an applicant had committed a serious crime in one country, but migrated from a different country, then they could, by not declaring the country where the crime was committed, get around the law. A partial solution is to require all IMGs and applicants who have acquired Australian residency (TR, PR) or citizenship other than by birth, to undergo a check at time of initial and/or reregistration from the country they have emigrated from.
