Dear Mr Fletcher

I write in relation to the funding determination for the 2020–21 financial year, as required under section 26A of the *Health Practitioner Regulation National Law (Queensland)* (National Law).

As you would be aware, the National Law requires consultation with the Australian Health Practitioner Regulation Agency (AHPRA), the National Boards and the Health Council prior to the approval of the final funding determination amount. Thank you for your response, dated 28 May 2021, to the consultation paper on the proposed determination on behalf of AHPRA and the National Boards. The consultation feedback received has endorsed the proposed determination.

I confirm my decision that for the 2020–21 financial year, the total sum of the complaint's component of registration fees payable by Queensland Health Practitioners is \$4,243,624. I have enclosed a summary of the amounts payable by each of the National Boards. In accordance with the National Law, could you please ensure that the National Boards are notified of the required contributions and that you publish this decision as soon as practicable.

As part of its operational budget process, the Queensland Department of Health has already made payment to the Office of the Health Ombudsman which includes the estimated funding determination amount. The Department of Health requests that the 2020–21 final funding determination payment of \$4,243,624 is made directly to the Department. I have made arrangements for the Department to raise an invoice to facilitate this payment.
