

# **CMBA Regulatory Examinations Policy**

August 2021

Requests for reasonable adjustments for multiple-choice question examination candidates

#### **Purpose**

This document sets out the Chinese Medicine Board of Australia's (CMBA's) policy for assessing requests for reasonable adjustments for candidates sitting the CMBA regulatory examinations for overseas-qualified Chinese herbal medicine practitioners and acupuncturists (candidates).

#### **Scope**

The CMBA regulatory examinations includes a multiple-choice question (MCQ) examination and an objective structured clinical examination (OSCE).

The CMBA's policy in this document on requests for reasonable adjustments applies to the MCQ examinations for all divisions.

#### **Policy**

#### Reasonable adjustments

Reasonable adjustments (also known as testing accommodations) are special arrangements for the administration of the MCQ examination to provide candidates with disabilities (physical or mental impairment/s) full access to the examination where possible. Reasonable adjustments must be made in line with the inherent requirements for safe and competent Chinese Medicine practice in Australia and must not compromise the integrity of the examination. The expected level of clinical competence is the same for all candidates and cannot change as part of a reasonable adjustment arrangement.

Certain items (e.g. medicines, medical devices and mobility devices) do not require a request for reasonable adjustments and are allowed into the examination room if they do not produce sound that will potentially distract other candidates. The examination centre staff may allow candidates to take these items into the examination room without pre-approval, subject to a visual inspection of the item by examination centre staff.

Medical devices such as insulin pumps, some glucometers, etc. that are attached to the body require a request for reasonable adjustments. Devices that do not produce sound or potentially distract other candidates will be allowed into the examination room. If a candidate has a device that does produce sound, Ahpra would need to request a separate room for that candidate and may require the candidate to reimburse Ahpra for any additional cost charged for that separate room.

Requests for reasonable adjustments to examinations because English may be a candidate's second language will not be considered, even where a candidate believes that this impairs their ability to pass the regulatory examinations. Proficiency in English is a mandatory requirement for registration in Australia.<sup>1</sup>

Requests for reasonable adjustments to examinations because a candidate experiences anxiety or phobias will not be approved unless supported by a specific and professionally recognised diagnosis

found in the Diagnostic and Statistical Manual of Mental Disorders (DSM). Test/examination anxiety is not a recognised diagnosis according to the DSM.

#### MCQ examination

Scope of request for reasonable adjustments to the MCQ examination

Candidates can only request the following adjustments to the MCQ examination arrangements:

- Extra time
  - Candidate receives additional time to complete the MCQ examination. For example, an additional 30 minutes, 45 minutes or 60 minutes.
- Separate room
  - Candidate can undertake the MCQ examination in a room that is separate to any other candidates. Ahpra may require the candidate to pay for any additional cost incurred for these arrangements.
- Adjustable font size
  - During the MCQ examination, the candidate can adjust the text size on the screen to make it larger or smaller.
- Adjustable contrast
  - During the MCQ examination, the candidate can adjust the brightness and/or colour of the text and/or background at any time.

#### Request for reasonable adjustments

Candidates must submit a request for reasonable adjustments to the MCQ examination to Ahpra at the time of registering for the MCQ examination as soon as practicable after registering, and no later than 30 business days prior to the scheduled MCQ examination date.

The candidate requesting reasonable adjustments must write and present supporting documentation to <a href="mailto:cmbaregulatoryexam@ahpra.gov.au">cmbaregulatoryexam@ahpra.gov.au</a>

Appropriate documentation supporting the request for adjustments must be provided by the candidate at the time of the request and must include, at a minimum, a letter from a registered medical practitioner describing the candidate's disability/impairment and recommendations for reasonable adjustments with a stated rationale as to why the medical practitioner considers the requested adjustments are necessary and appropriate for the disability/impairment..

If the request relates to a diagnosed disability or impairment, the candidate must arrange for results of diagnostic testing and/or a report to be submitted by a qualified professional with expertise in the area of the diagnosed disability or impairment. The report (or supporting documentation) could include:

- A history of the disability/impairment and any past adjustment(s) granted to the candidate, as well as a
  description of the impact that the disability or impairment has on the individual's functioning
- Identification of the specific standardised and professionally recognised test/assessments given (e.g., Woodcock-Johnson, Weschler Adult Intelligence Scale)
- The scores resulting from testing, interpretation of the scores and evaluations, and
- Recommendations for reasonable adjustments with a stated rationale as to why the recommended adjustments are necessary and appropriate for the diagnosed disability/impairment.

### Ahpra's assessment of the request

Ahpra will assess each candidate's request for reasonable adjustments to the MCQ examination, including the supporting documentation. This assessment will be completed as soon as possible, and not more than 20 business days, after Ahpra receives all the information.

After assessing the request, Ahpra must consider whether the requested adjustments are reasonable for the candidate's needs, based on the candidate's request and supporting documentation. Ahpra's assessment will also consider the inherent requirements of safe and competent Chinese Medicine practice in Australia and the CMBA's standards, codes and guidelines applicable to disabilities and impairments. Ahpra legal advice will be sought where required.

If Ahpra considers the requested adjustments are reasonable, Ahpra will inform Kryterion about the requested adjustment.

If Ahpra does not consider the requested adjustments are reasonable, Ahpra will notify the candidate of the outcome of Ahpra's assessment of their request, including the reasons for the outcome.

If the candidate does not agree with the outcome of Ahpra's assessment of the request for reasonable adjustments, the candidate may apply for further review by the CMBA Examinations Committee. The candidate must pay the relevant fee at the time of requesting the review.

#### CMBA Examinations Committee review

The CMBA Examinations Committee review will assess the request and supporting documentation, including any request for a review of Ahpra's assessment of the request.

Candidates must apply for a review by the CMBA Examinations Committee within five business days of being notified of the outcome of the Ahpra's assessment of the request for reasonable adjustments. The candidate must pay the relevant fee at the time of requesting the review.

There are two reasons for seeking a review by the CMBA Examinations Committee:

- The candidate believes that the manner in which the *Reasonable adjustments for MCQ examination* policy has been followed was procedurally unfair.
- The candidate believes that the outcome of Ahpra's assessment of the request for reasonable adjustments is unfair or unreasonable on the basis of the available evidence.

All records relating to the review of the candidate's request for reasonable adjustments will be made available to the CMBA Examinations Committee, including information supplied by the candidate. The candidate has the right to appear before the CMBA Examinations Committee.

The CMBA Examinations Committee review findings may be:

• The original outcome of Ahpra's assessment of the request for reasonable adjustments is upheld. The original outcome of Ahpra's assessment of the request for reasonable adjustments is not upheld Where the original outcome of Ahpra's assessment of the request for reasonable adjustments is not upheld, the CMBA Examinations Committee will determine a new outcome and will advise that review fee may be refunded in full or in part.

The CMBA Examinations Committee will advise Ahpra of the outcome of their review.

Ahpra will notify the candidate in writing as soon as practicable following the CMBA Examinations Committee review decision and provide reasons for that decision.

#### Monitoring, evaluation and review

This policy will be reviewed from time to time as required. This will generally be at least every three years.

#### **Definitions and abbreviations**

**CMBA regulatory examinations** are used by the CMBA to assess overseas-qualified Chinese herbal medicine practitioners and acupuncturists who apply to register in Australia and who are assessed as holding a qualification that is relevant but not substantially equivalent or based on similar competencies to an Australian approved qualification (and who meet the mandatory registration standards).

**Inherent requirements are** the core activities, tasks or skills that are essential to a workplace in general, and to a specific position or role as a Chinese medicine practitioner or acupuncturist in Australia. The activities and/or tasks cannot be allocated elsewhere, are a core element of the position or role, and result in significant consequences if they are not performed.

**Reasonable adjustments** are special arrangements for the administration of the examination to provide candidates with physical or mental impairments full access to the examination without compromising the integrity of the examination and ensuring all candidates are assessed to the same level of competence.
