SUBMISSION: REVISED REGULATORY PRINCIPLES

BACKGROUND:

Over the past 12 years, I have submitted notifications to the regulators AHPRA, HCCC, and OHO concerning 185 chiropractors. In every case my 'notification' was detailed, referenced, evidenced, and demonstrated contraventions of science, Codes of Practice, the National Law, and Consumer Law. In many cases my notification was ignored, going by the failure of the chiropractor concerned to change their advertising.

In all of those 185 notifications to regulators, in only one case have I been informed of any action from them, and in that case it was because I accidentally came across a change to his registration details on the AHPRA website. In that case the chiropractor had conditions placed on his public registration that he must not engage in antivaccination activity. Where I have been informed of an outcome it is simply a letter advising me that the case is closed. The only way I have of finding out what happened is to look at the registry. There is no evidence available to me that the regulators took any action concerning the complaints about the other 184 chiropractors.

Lists of the conditions that chiropractors claim to treat, and which I have reported, are at Appendix 1. All of those claims are not evidence-based and are exploitative, even dishonest. In most cases the regulators have failed to act. It would be fair to say that the current regulatory regime places the finances and image of the chiropractic industry and feelings of chiropractors over public safety.

THE DRAFT PRINCIPLES:

I see that in the draft Principle 5 'minimum regulatory force' has been changed to 'apply the necessary regulatory response.'

At first glance, this appears to be a welcome improvement. Until today, when exposed by a notification to AHPRA/HCCC/OHO, chiropractors have received nothing more than a friendly phone call asking them to fix their advertising, often not even that.

This is an appalling neglect of the need to protect public safety and prevent exploitation. Fixing their advertising does not ensure that their practice is complaint; there are no on-site inspections of their practice and records to determine that.

Further, there are no routine on-site inspections. Such is the process in the aviation industry where the safety regulator, CASA, conducts on-site inspection of operators with and without notice, provides advice where improvements are needed, and applies sanctions where appropriate. None of that happens in the chiropractic industry, and it shows.

Finally, there is no evidence that chiropractic is safe. In the absence of a Mandatory Reporting System of Adverse Events. All we have are anecdotes and unsubstantiated claims. Such a mandatory reporting system exists in the aviation industry, with strict requirements for reporting and penalties for failing to do so.

CONCLUSIONS

It is clear that the regulators and the State and National Chiropractic Boards are failing to ensure that the public is treated safely and is not exploited. The current principles and practices are woefully deficient, with current emphases placed more on protecting the chiropractic industry and individual chiropractors.

RECOMMENDATIONS:

So, I recommend:

- 1. Response to a notification must lead to an investigation that goes beyond a phone call asking the practitioner to fix their advertising. That investigation must determine if the practitioner was in breach of the Codes of Conduct and legislation.
- 2. The Revised Regulatory Principle number 5, 'apply the necessary regulatory response,' needs to be defined. 'Necessary' and 'response' are entirely in the eye of the beholder and can be taken to mean 'a friendly phone call.' In other words, no change to the current regime. The definition should be 'apply financial penalties and educational requirements, suspension, apply conditions to registration.'
- 3. Penalties and conditions must be placed on AHPRA's public registration page.
- 4. On- site inspections to be introduced as a Standard Operating Procedure, with and without notice.
- 5. A Mandatory Adverse Event Reporting System to be introduced, with penalties for failure to comply.
- 6. People who submit a notification must be informed of the outcome of their report.

APPENDIX 1.

CHIROPRACTORS' CLAIMS

These are some of the conditions that some chiropractors claim to treat, have published advice that is contrary to the established science, or claim to use ineffective techniques and machines. In every case except the last three all have been reported to the regulators. Those items marked with an * have been the subject of warnings from the Chiropractic Board; those without were ignored.
