Since getting repeats on scripts like these is frowned on, I only get 1 month supply at a time, and my doctor will not prescribe the next month unless I am down to 3 days left or less. Juggling this around 3 different prescriptions means that I often need a Telehealth with short notice in order to get my prescriptions in time.

It would prevent me being able to fill my scripts as I am reliant on others to drive me if I cannot do Telehealth and I don't have anyone to do that. I cannot afford an Uber, living in the tiny amount of money I am capable of bringing in each week, and I am physically incapable of using public transport.

When I don't get access to my meds, even a day without taking them has a massive effect and sends me suicidal. If it's a few days, I will likely attempt, and I will succeed. And my family and friends are all waiting in line to tell the media (of whom they know many, personally) that my suicide was caused by these actions making my difficult life that much more difficult, and bringing everyone who approved this decision to blame for my death naming them each in turn.

I don't want to die but if it means things get better for everyone else and we stop cutting essential and helpful medical things that people need - that would make it worth it.
